FOAL/ PONY REGISTRATION

Before completing this application please familiarize yourself with current legislation & guidelines surrounding equine registration.

This will explain the Responsibilities of Keepers and Owners of Equine Animals – i.e. Horses, Ponies and Donkeys

- 1. This registration form must be completed by a person other than a CPBS representative.
- 2. The sire and dam must be registered with the CPBS before a foal/pony can be registered.
- 3. The CPBS will not accept registration applications without breeding particulars.
- 4. If you are unsure of the correct **sire** you can submit 2 additional **sires** on this application free of charge.
- 5. If the sample results in an exclusion repeat sample will be required & additional fee's will be incurred.
- 6. You will need a valid equine premises number to register your pony. https://cpbs.ie/equine-premises-number/
- 7. A maximum of 30 characters (including spaces) can be used in a name. Names exceeding this will not be accepted.
- 8. A Lifetime Document will be issued for each animal when its parentage and HWSD status are verified to the CPBS.
- 9. If your registration is exempt from HWSD testing & results as an exclusion you may have to apply for a HWSD test.
- 10. The CPBS will issue the passport to the registered owner i.e. the person who applies for the DNA kit.
- 11. Membership rates apply to current members of the Society only. Membership is NOT Transferrable.
- 12. Incomplete applications & those accompanied by the incorrect/ No fee, equine premises number issues will be returned.

Changes to our Sampling Process.

As you may be aware the equine industry is changing its method of DNA testing. With this transition you will notice some differences in your DNA kits and processes involved. We will include clear instructions with your DNA kit please take time to read these carefully before proceeding with the sampling. Some of the changes are as follows:

1) You may be required to submit a sample from the dam of your foal.

If so you must present the mares passport to the veterinary surgeon when getting your foal marked.

- 2) The veterinary surgeon must correctly identify the mare by completing the following steps.
 - I. Scan the mare for a microchip.
 - II. Compare this full 15-digit microchip number to the microchip listed in the passport.
 - III. When the mare is correctly identified proceed with the foals sampling, marking & microchipping.
 - IV. Please take care when sampling as exclusion's will require repeats for all ponies included in the covering and additional costs incurred.

If no chip is present/scanning in the mare please contact the CPBS Office 095-21863. Please note: Samples & marking charts must be submitted together to the CPBS from the owner/keeper.
